

Tree Planting on Private Land Program – Spring 2026



LPRCA Tree Planting Service

Long Point Region Conservation Authority (LPRCA) has trees and grants available for Spring 2026. Landowners in the Long Point Region Watershed may be eligible to participate in tree planting and landscape restoration services delivered by LPRCA.

LPRCA's experienced staff will assist qualified landowners in restoring and improving their property by supplying and planting trees and shrub seedlings. Landowners choosing LPRCA's services may also be eligible for subsidies on the cost of their planting project.

Eligible planting projects may include field windbreaks, buffer strips along a watercourse, habitat restoration, establishing tallgrass prairie and reforesting erosion-prone lands.



Landowner Eligibility

Landowners who reside in the Long Point Region watershed and own a minimum of 5 acres (2 hectares) are eligible to participate in the program. Trees purchased through this program may be planted by the landowner or through LPRCA's full planting service. A minimum of 500 seedlings must be planted to qualify for tree planting services. To plant the trees yourself, a minimum order of 150 seedlings of one species is required. No quantity requirements after.
